

FACTS	WHAT DOES S2 FUNDING, LLC DO WITH YOUR PERSONAL INFORMATION?	
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security number and income • Account balances and payment history • Transaction or loss history and employment information • Credit history and credit scores When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons S2 Funding, LLC chooses to share; and whether you can limit this sharing.

What we do	
How does S2 Funding, LLC Protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also maintain physical, electronic and procedural safeguards such as computer virus protection software, firewalls, and a 128 bit Secure Socket Layer. Only authorized employees have access.
How does S2 Funding, LLC collect my personal information?	We collect your personal information, for example, when you • Give us your income information • Provide employment information • Provide account information • Give us your contact information • Show your driver's license We also collect your personal information from others, such as credit access businesses like MK PayDay LLC, credit bureaus or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only • Sharing for affiliates' everyday business purposes-information about your creditworthiness • Affiliates from using your information to market to you • Sharing for non-affiliates to market to you. State laws and individual companies may give you additional rights to limit sharing. If you limit sharing for an account you hold jointly with someone else, your choices will apply to everyone on your account.
Definitions	
Affiliates	Financial and nonfinancial companies related by common ownership or control. • <i>S2 Funding, LLC does not share with its affiliates.</i>
Non-affiliates	Financial and nonfinancial companies not related by common ownership or control. • <i>Non-affiliates we may share with can include credit access business, MK PayDay LLC, collection agencies, lenders, tax preparers, prepaid card providers, banks, debit card companies, companies that provide discounts to employees like Multikrd LLC.</i>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • <i>Joint marketing partners include lenders, credit access businesses like MK PayDay LLC, banks, prepaid card companies, debit card companies, institutions that promote our products like companies that provide discounts to employees like Multikrd LLC.</i>
