Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Joint marketing partners include lenders, banks, prepaid card companies, debit card companies, institutions that promote our products like Multikrd LLC that provides benefits discounts to individuals.
